MOTION #1

1. The Vi Hunsucker Award Ad hoc committee moves that Section VII 4 Awards of the NCSTA Handbook be changed to read as follows:

The Vi Hunsucker Outstanding Science Educator of North Carolina Award is named in honor of NCSTA Founder and First President, Violet (Vi) D. Hunsucker. Vi Hunsucker helped start the organization in 1969 and continued to provide leadership as it grew and expanded. This award recognizes long-term commitment and loyalty to the North Carolina Science Teachers Association, as well as accomplishments beyond one's employment duties, that advance, stimulate, extend, and improve the teaching and learning of science within the state. This award may honor formal science teachers, elementary teachers engaged in science instruction, informal science educators, or patrons of /or ambassdors for NCSTA who have made significant contributions to NCSTA and have provided excellence in science education at all grade levels in North Carolina.

When given, the winner of the Vi Hunsucker Outstanding Science Educator of North Carolina Award is to be presented with an award at the annual conference (PDI). The Awards Committee does not disclose the identity of the Vi Hunsucker honoree until the presentation at the PDI awards ceremony.

This honor is not a yearly award. It recognizes an exceptional NCSTA member who has demonstrated long-term commitment to the Association and advancement of science teaching and learning in the state of North Carolina.

If nominations are received for this honor, a special Ad Hoc committee composed of the Awards chair, a sitting NCSTA Board member, and a past Vi Hunsucker Awardee will formed to review and assess the nominations and supporting documentation for the Vi Hunsucker Outstanding Science Educator of North Carolina Award to determine if the criteria is met and the award is warranted.

To maintain relevancy and clarity, periodic assessments will be made to determine whether or not an ad hoc committee formation is necessary to review the existing criteria and selection process for the NCSTA Vi Hunsucker Award.

The website should be updated to be in agreement with this policy.

MOTION #2. The Vi Hunsucker Award Ad hoc committee moves that the NCSTA Board approve the

following nomination and selection process for the Vi Hunsucker Outstanding Science Educator of North Carolina Award.

A separate page will be placed on the NCSTA website regarding the Vi Award.

A nomination form will be on the website that allows for the nominee to submit

information and evidence for each of the 4 award criteria that supports the individual being considered for the Vi.

Endorsement letter(s) will be emailed to the Awards Chair.

When nominations for the Vi are received and the Awards Chair deems the nominee has sufficient evidence to meet criteria #1, Long term loyalty and commitment to NCSTA, the Chair of the Awards committee forms an ad hoc group composed of the Chair, a sitting Board member and a former Vi winner to use the scoring matrix for the Vi Hunsucker Award to assess the evidence submitted on the nominee's behalf. Based on this assessment, this Ad Hoc committee determines if the individual qualifies for the award. The Vi Award is not given yearly, but only if a nominee meets/surpasses the Criteria.
